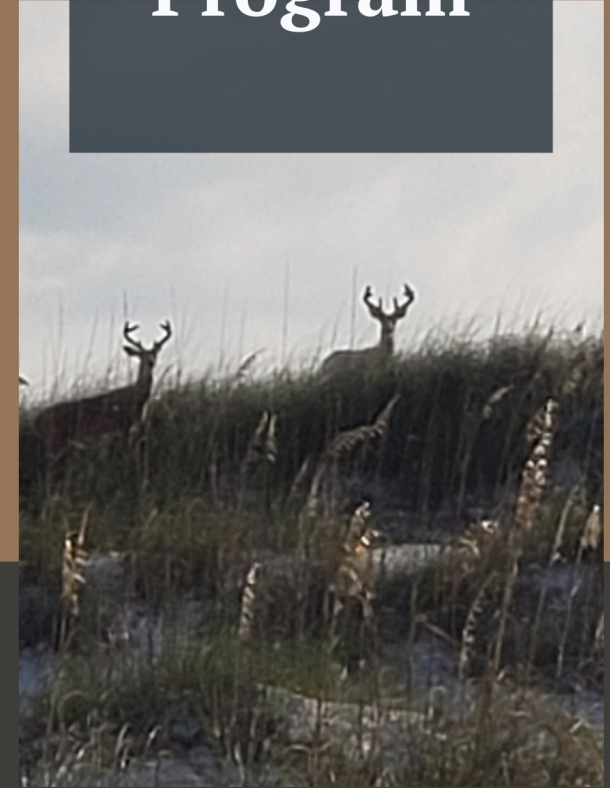

Transporting loaded firearm in a vehicle

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
No FWC violation.

Possession of a firearm while hunting deer during archery only season

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
No FWC violation. Possession alone does
not constitute a violation.

Failure to wear a safety harness or strap while in elevated stand

TAFB Penalty: First Offense 1 year ban
Second Offense 2 year ban
No FWC violation. Tyndall only.

Failure to check in/out properly at the check station

TAFB Penalty: First Offense 6 month ban
Second Offense 1 year ban
No FWC violation. Tyndall only.

Failure to record harvested biological data to check station

TAFB Penalty: First Offense 6 month ban
Second Offense 1 year ban
No FWC violation. Tyndall only.

Theft of personal property or damage of another hunter's equipment (vehicle, accessories, etc.)

TAFB Penalty: Permit Revocation
FWC Penalty: Varies from 1st to 2nd degree misdemeanor.
Possible felony depending on monetary amount.

Discharging a firearm from a vehicle

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
FWC Penalty: F.A.C. 68A-12.002 (6) Game birds and mammals may be taken from stationary vehicles. 2nd degree misdemeanor. Notice to Appear (NTA)

Possessing illegally harvested game

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
FWC Penalty: Illegal method of take or during closed season. 2nd degree misdemeanor. (NTA)

Hunting w/ unauthorized weapon or ammunition

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
FWC Penalty: F.A.C. 68A-15.063 (18)(D)(4)
The use of handguns, rimfire and centerfire rifles are prohibited for taking wildlife. 2nd degree misdemeanor. (NTA)

Hunting w/out a valid state hunting license or Tyndall AFB Permit

TAFB Penalty: First Offense 1 year ban
Second Offense Permit Revocation
FWC Penalty: Non-criminal infraction.
Payable fine.

Hunting out of installation seasons

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
FWC Penalty: 2nd degree misdemeanor. (NTA)

Placing bait or hunting over or taking game over baited areas.

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
FWC Penalty: F.A.C. 68A-15.004(10) No person shall place, expose or distribute any grain or bait. 2nd degree misdemeanor. (NTA)

Illegal use of artificial light for locating game or hunting

TAFB Penalty: First Offense 3 year ban
Second Offense Permit Revocation
FWC Penalty: 68A-4.002 (1) Illegal take of wildlife at night.
2nd degree misdemeanor. (NTA)

Hunting in a closed area

TAFB Penalty: First Offense 1 year ban
Second Offense 3 year ban
FWC Penalty: 2nd degree misdemeanor. (NTA)

Failure to wear the approved type and minimum amount of fluorescent orange

TAFB Penalty: First Offense 1 year ban
Second Offense 3 year ban
FWC Penalty: F.S. 379.3003 Hunter orange requirement. Non-criminal infraction.
Payable fine.

Littering or dumping

TAFB Penalty: First Offense 6 month ban
Second Offense 1 year ban
FWC Penalty: Varies from non-criminal infraction to 2nd degree misdemeanor. (NTA)

Failure to properly record harvest IAW state requirements prior to moving animal from location of kill

TAFB Penalty: First Offense 1 year ban
Second Offense 3 year ban
FWC Penalty: Non-criminal infraction.
Payable fine.

Exceeding bag limits

TAFB Penalty: First Offense 1 year ban
Second Offense 3 year ban
FWC Penalty: 2nd degree misdemeanor. (NTA)

Possession of open container of alcoholic beverage on person or use of illegal drugs while hunting

TAFB Penalty: First Offense 1 year ban
Second Offense 3 year ban
FWC Penalty: Varies from non-criminal infraction to 2nd degree misdemeanor. (NTA)

Hunting/running deer with dogs

TAFB Penalty: First Offense 1 year ban
Second Offense 2 year ban
FWC Penalty: F.A.C. 68A-15.063 (18)(D)(1)
Taking wildlife with dogs is prohibited.
2nd degree misdemeanor. (NTA)

Illegal harvest of an antlered deer (4 or more points) not meeting QDM requirement (4 on a side)

TAFB Penalty: First Offense 1 year ban
Second Offense 3 year ban
FWC Penalty: F.A.C. 68A-15.063 (18)(B) Legal to take game-Required to have 1 antler with at least 4 points. 2nd degree misdemeanor. (NTA)
